

Exceder LED3 Blue Lens Strobes



Description

The Wheelock Exceder™ LED3 blue lens strobes by Eaton feature an advanced power saving LED technology in a sleek, modern, single-gang enclosure (wall models) that will provide high energy efficiency and an aesthetically pleasing low profile design that will blend with the building's interior décor. The LST3-B blue lens appliances are ideal for indoor, ceiling and wall-mount mass notification and emergency communication applications.

Strobe models feature field selectable candela settings: 3, 6, 15, 22 cd for wall models and 3, 6, 15, 19 cd for ceiling models.

Compliant and Compatible

Eaton's Exceder LED3 strobes meet the 20 millisecond light pulse duration requirements of the 2016 edition of NFPA 72. By meeting this latest requirement, xenon and LED devices can now be in the same field of view. With the Exceder LED3 line, Eaton now offers a full range of products with low and high candela settings ideal for both retrofits and new construction.

Low Profile Design and Feature Set

With the industry's smallest footprint, the Exceder LED3 strobes are aesthetically pleasing to building owners as the low profile design does not detract from the interior decor. Installers will benefit from its comprehensive feature list, including lowest current draw, single-gang design, no tools needed for setting changes, and three convenient mounting options for both new and retrofit construction. These products are suitable for indoor wall-mount applications. The LST3 strobes are for 24V operation.

Approvals and Synchronization

The Exceder LED3 blue lens strobes are listed under UL Standards 1638 for general signaling and ULC listed under CAN/ULC-S526 (Visual Signal Appliances). The appliances are Restriction of Hazardous Substances (RoHS) compliant and contain no mercury or other hazardous substances.

In addition, the Wheelock Exceder LED3 product line has been UL/ULC listed as compatible with all Fire Alarm Control Panels (FACP) and accessories that have been determined to be compatible with Wheelock RSS strobe-based products including the RSS, CH, E, EH, ET, ST, HS, MT, S8, SA, STH and Z Series. The listing also includes the ability to install the Exceder LED3 strobes in the same notification zone and field of view with any Wheelock RSS strobe models.

General Notes

- Strobes are designed to flash at 1 flash per second minimum over their "Regulated Voltage Range." Note that NFPA-72 specifies a flash rate of 1 to 2 flashes per second and ADA Guidelines specify a flash rate of 1 to 3 flashes per second.
- All candela ratings represent minimum effective Strobe intensity based on UL 1638




Figure 1. Wall Strobe




Figure 2. Ceiling Strobe

Architects and Engineers Specifications

The LED blue lens strobe appliances shall be Wheelock® Exceder™ LED3 visual strobe appliances, LST3-B for wall-mount applications and LSTC3-B for ceiling-mount applications with a low-profile design or approved equals. Special lettering, including ALERT lettering and no lettering shall be available. The LST3-B/LSTC3-B strobes shall be listed for UL Standard 1638 (Visual Signaling Appliances for emergency notification). All inputs shall be compatible with standard reverse polarity supervision of circuit wiring by a Fire Alarm Control Panel (FACP) with the ability to operate from 16 to 33 VDC.

The LST3-B/LSTC3-B blue strobe appliances shall produce a flash rate of one (1) flash per second over the Regulated Voltage Range and shall incorporate a Light Emitting Diode (LED) as the light source with a rugged Lexan® lens. The Series shall be of low current design. The LED strobe flash duration shall be 20 ms. The strobe intensity shall have 4 field selectable settings at 3, 6, 15, 22 candela output for wall mount applications and 3, 6, 15, 19 candela output for ceiling mount applications. The selector switch for selecting the candela shall be tamper resistant. Appliances with candela settings shall show the candela selection in a visible location at all times when installed.

The series LST3-B strobe shall include Exceder LSBB backboxes, single-gang backbox and to 4" square with adapter kit for wall mount applications, and the LSTC3-B strobe shall include LED Ceiling backboxes, 4" square, 1 1/2 or 2 1/8" deep and 4" Octagonal, 1 1/2" or 2 1/8" deep for ceiling mount applications. Two wire appliance wiring shall be capable of directly connecting to the mounting base. Removal of an appliance shall result in a supervision fault condition by the Fire Alarm Control Panel (FACP). All notification appliances shall be backwards compatible.

The series LST3-B wall models shall have a low profile measuring 4.53"H x 2.76"W x 1.27"D. LSTC3-B ceiling models shall have a low profile measuring 6.26" Diameter with 1.5"D.

When synchronization is required, the appliance shall be compatible with Wheelock®'s DSM Sync Modules, PS Power Supplies, SAFEPATH products or other manufacturer's panels with built-in Wheelock® Patented Sync Protocol. The strobes shall not drift out of synchronization at any time during operation. If the sync protocol fails to operate, the strobe shall revert to a non-synchronized flash-rate and still maintain (1) flash per second over its Regulated Voltage Range.
